Single-family residential properties will not be charged for sewerage usage above 12 CCF. Residential properties receive an automatic green credit of 25% on the drainage charge with the assumption that you have redirected your downspouts to run onto your lawn instead of directly into the sewer. Non-residential properties also have the opportunity to reduce your drainage charge by improving onsite stormwater management – visit www.detroitmi.gov/drainage to learn more.
